

DJSI 2024 Rebalancing - Supplementary Information

The S&P Global Corporate Sustainability Assessment (CSA) provides CSA Scores, which are among the key factors considered for determining eligibility of companies for potential inclusion in the Dow Jones Sustainability Indices (DJSI). S&P Global Sustainable1 conducts and manages the CSA independently from S&P Dow Jones Indices, a global index provider and an independent affiliate of S&P Global.

3,563 companies were eligible for potential index inclusion in 2024. Read the full [DJSI methodology](#). All eligible companies were invited to participate in the CSA. Find out more about the [CSA methodology](#).

The CSA Score Table provides a point-in-time snapshot of rounded CSA Scores dated November 22, 2024 (Score Cut-Off Date). Non-rounded Scores were submitted by S&P Global Sustainable1 to S&P Dow Jones Indices for consideration in the DJSI rebalancing effective on December 23, 2024.

In the table below CSA Scores can represent:

- (1) An assessment based on a company's active CSA participation (Score type: CSA Participant).
- (2) An assessment based on publicly available information should a company not have informed S&P Global about its intention to participate in the CSA before the Score Cut-Off Date (Score type: Public Assessment).
- (3) A preliminary assessment based on public information for companies that confirmed active participation in the CSA and whose assessment was not completed by the Score Cut-Off Date. (Score type: Public Assessment (Preliminary Score)).¹

CSA Scores that are flagged as "Preliminary Score" are only produced for S&P Dow Jones Indices for the purpose of having a score at the Score Cut-Off date for the potential selection of companies into any Dow Jones Sustainability Index. They are otherwise only made available in this document and not shared on S&P Global's professional platforms or ESG Scores website.

CSA Scores may change after the Score Cut-Off Date for different reasons, following the application of the S&P Global CSA methodology and related processes, including active participation by a company in the CSA resulting in a participation-based score after the Score Cut-Off Date. Updated CSA Scores will be available, as applicable, on S&P Global professional platforms and the public [ESG Scores website](#).
